A fee estimate for your work will be provided upon initial instruction.

The exact number of hours it will take to undertake your matter depends on the circumstances in your case. Such as:

- The amount of supporting evidence that we need to consider
- Which language(s) you speak
- Whether you are applying with other dependants

If you are able to provide sufficient evidence at our first meeting and clearly meet the applicable Immigration Rules, are costs are likely to be lower.

What services are included?

The work will involve:

- Discussing your circumstances in detail and confirming whether this is the most appropriate application for you to make and what other options may be available to you
- Giving you advice about the requirements of the Immigration Rules and whether you meet the criteria.
- If you do not fulfil certain criteria, whether this can be overcome and how, which on average takes three to four hours.
- Considering the supporting evidence you have provided, which we anticipate will take three to four hours. However, the amount of hours depends on the number of documents, whether they need to be translated, whether anything is missing and how long it will take to obtain the missing documents
- Where necessary, helping you obtain further evidence (such as medical records and bank statements), including taking statements of any witnesses
- Preparing your application and submitting it on your behalf, which we anticipate will take up to fifteen hours (but certain cases may take more time, if this applies, you will be notified)
- Attendance at a Home Office interview: if the Home Office ask you to attend an interview, we will give you clear advice (and discuss the possibility of us attending with you) at the appropriate time. This could be between eight and ten hours of work.
- Giving you advice about the outcome of the application and any further steps you need to take.

Disbursements (not included in costs set out above)

Disbursements are costs related to your matter that are payable to third parties, such as visa fees, healthcare surcharges, biometric charges. We handle the payment of the disbursements on your behalf to ensure a smoother process.

- Interpreters fees to be quoted separately and if necessary.
- Independent expert reports e.g. medical experts. These are not required in many cases: we will let you know as soon as possible if we consider an expert report is necessary.
- If there is an interview and we do attend with you, there will be additional disbursements in respect of our mileage/travel expenses.

The costs quoted above do not include:

- Any Home Office fees for making the application. You may pay this to the Home Office directly as part of the application process or provide us with card payment details to facilitate payments. For information in relation to home office fees, [please read here](#).
- Where the Home Office refuse your application, advice and assistance in relation to any appeal
